## 3) Quarterly financial review (9:20 am - 9:40 am)

1. 2022 Budget review

Overall remarks: we are on version 4 of the yearly budget

It was a collaboration between Camille, Rory and Kayla.

Camille will present on the budget per class and Rory will provide overview of the budgeting process and suggestions for management in 2022

## Admin:

- this class includes all of our overhead a majority of this expense was covered by the CEBA loan and will be paid back through differed admin expenses
- still need to have year-end financial meeting with Clelie to determine carry-over amount for each class
- CEBA loan: put into a 1-year 90-day term deposit to accrue interest will pay back in September/October (deadline is
  December 2022 advised to pay back in November 2022) We have currently spent the \$30,000 will have \$10,000 forgiven
  and added to our overhead fund (chequing account balance) -will present P&L breakdown next meeting



Admin fees are estimated to include the total amount we expect to get if all grants are

#### awarded

High ending balance because wage funding goes directly into this account

#### 1b & 1c:

- These are our expected deficits use these as fundraising goals total deficit comes out of total admin expense
- Include time spent developing outreach programs

#### KLS:

- Reach our fundraising goal event to take place in March
- Almost balances small donation goal due to it being online

#### KLEP:

- KLEP just the podcast for now
- Will include LYL survey once we commence it in 2023 when we have more capacity ie less big restoration projects

#### WR:

- Big project for 2022 confirmed funding from CBT
- High expenses in professional fees and materials etc..
- End with revenue but this is based on getting all of our large grants

## KSSR:

- Carryover into 2022 is high but it goes until March 2022
- Can do more with this funding more time allotted to outreach, education etc

## BC:

- Hitting the ground running in the spring with a lot of carry over
- Funders like this program but it doesn't cost a lot to coordinate
- This is good because it lessens our ask on RDCK for CIP

#### OSP:

- This budget is always pretty skinny but it balances this year
- 2022 will mark the completion of our documentary and doing the 5-year report

#### WQM:

- This project has lots more potential to expand our outreach
- Needs to be spent out by July 2023
- Could fund community-based water monitoring podcasts etc..
- Could use funding to hire someone with CABIN data entry experience

## Total by Quarter:

- Looks like If we get all of our grants this year we will
- finish with a large overhead
- This means we will need to spend this money -which means opportunities such as additional staff to run programs and more outreach!
- If our admin budget looks this robust perhaps we can purchase additional tech and a health spending account for staff to have them and their families covered for medical.

Our primary concern is Kootenay Lake – impacted by Libby Dam and Duncan river.

Statement out of FoKL that says what our concerns are

Waterbed effect what we change here effects other systems Koocanusa and

Kootenay Lake would have flooded 10 feet higher, blocked the river inflows which brought nutrients

Blocked the passage of bull trout to spawn, sturgeon decimated by the libby dam

Wetlands have been impacted by diking

Greg is working to create models for flow management changes

Asking for compensation would be plan B, change in management is plan A

Managing the lake levels to

Any way to get nutrients into Kootenay Lake from main tributaries?

Fish passages

We have no say with Libby or control -we need to have mutual agreement

Sturgeon action forced by species at risk act

Duncan Dam can be changed how it is managed – there is potential

Only manage for flood risk in times of high potential

After 2024 we will not be paid for flood control – don't ask for more money ask for less flood control

A seasonal hydrograph of Harrop

Have a Kootenay system structure – FoKLSS to have a forum

FoKISS could ask for governance, education, funding, raise things that could happen but not have a fixed view on this.

Idea: have required readings for staff with discussions planned
