- CEBA loan integrated into General fund How did we come to this? Likely needs to be answered at the next Board meeting
 - CEBA Money was supposed to be kept separate so this didn't happen and NOT touched
- Gwen reviewed list of 'asks' and updated on current status.
 - •RDCK spoke with Garry Jackman said there's not much in Discretionary funds, but he gave a list of the Community Development \$ still available in each area

- Thurs is submission deadline for next RDCK meeting for projects to be presented to council (if we want them on the agenda for September 14th meeting)
- Normally would be 3rd Thurs of the month so Oct 19 would be next one
- Area A ask for top-up for WQM \$5000 Garry seemed very supportive
- Area D gave us nothing ask for total \$10,000 \$5000 for Osprey and \$5000 for WQM (mostly for staff time) – Greg suggested he could make this call and pitch for us
- Area E ask for \$10,000 (they have lots) Gwen has a bit of repoire with Cheryl will
 contact to see about topping up the Harrop wetland fund, again mostly staff time;
 could also make a case for some community involvement and informal training such
 as a 'Meet the wetland" (and recruit volunteers to do ongoing monitoring and

- maintenance; which Oleksandra would already like to do anyways); can also say I'm investigating the Milfoil study as a possibility for next year's funding
- Area F call Tom they have already given more than most; but can make a case for maybe a \$5000 top-up split between osprey monitoring, summit and beach cleanups
- Gwen will submit grant applications for Thursday afternoon deadline, once narrative refined
- Need to refine our narrative around the ask
 - FoKLSS is doing great work around / for the lake at a very cost effective rate
 - The world has gone upside down; significant staff turnover has contributed
 - Many grants applied for; some were declined and others at lower funding levels than requested; plus inflation of cost of implementation and the need to increase staff wages to keep staff has left a deficit in the coverage of staff time required to meet our project deliverables well
 - We need short-term support to make it through a rough spot so we can plan to move forward
 - We are in the process of applying for Charitable status will change funding prospects moving forward
 - Would give staff time to build financial systems to support Charitable status and adopt industry best practices
 - Are looking for local priorities to support and collaborations for the future
 - What projects could you incubate (ie. Up-front funding so that we can develop)
 - Looking at the possibility of RDCK providing ongoing CORE funding maybe \$10,000 per year talk to Sangita (for next year)
 - Also, we are initiating a fund raising campaign
 - LLC in addition to above message our work is complementary to Living Lakes objectives Camille will present to LL ask for \$10,000
 - Eco Canada wage funding for Oleksandra Gwen applied on Aug 25 takes 10 business days for response \$15,000
 - Fortis BC Gwen has a call arranged for Thursday with Blair Weston ask for \$10000
 - Suggested we not take CBT off the list, but not much hope ask for \$5000?
 - Alison at Selkirk College likely not funding but checking with her how to work together collaboratively in the future to include students in our work – volunteerism and/or project work of some kind
 - GoFundMe Jesse will look at putting together the campaign ask for \$15,000 again need messaging refined

- Maybe look to some of our local supporting organizations to help us with the publicity around this like Kootenay Lake Sailing Club Camille can help Gwen put together a list around this
- Regarding CEBA loan we need to make this a priority to be paid back by Dec 31 (current deadline) so we are not taking on \$40,000 debt perhaps if we are close to that point by year-end individual Board members may consider topping up so that we can make this happen
- However, lots of good ideas presented to be acted on going forward
